Terms and Conditions

Any one over the age 18 years may participate.

All new members are subjected to a waiting period of six months before the cover commences.

Cover under the scheme will cease if premiums are not 3 months

Premiums are paid upfront and any member with arears will not be able to claim.

Should main member die because of an accident a one (1) calendar month waiting period will apply.

Cover under this scheme will also cease in respect of a member when the contractor has deleted such a member from schedule.

If a member as mentioned in 5 above should re-join the scheme at a later stage the same conditions as for new membership will apply.

Cover under the scheme is provided on a month a month basis. No reserves are accumulated under the scheme; therefore, premiums are payable lifelong and there are no surrender values when ceases.

Premiums under the scheme are not guaranteed and can adjusted by the insurer at any stage
When a member increases his cover under the scheme the increased cover will be subject to the relevant waiting period before the full cover commences.

Membership under the scheme can only commence in the first day of the month

An application for membership, which is received during a month, will, if approved, only be accepted from the first day of the month following the receipt of the application. Cover will commence after the stipulated waiting period of 6 months.

No benefits are payable in the event of suicide within 24 months from inception date.

Claims procedure: All following documents must be completed and forwarded to Pyramid Funerals in the event of claim certified copy of death certificate, certified copy of ID book Bi1663. Claim will only be processed once all the necessary documentation has been supplied. Claim will only be finalized within 48hours after initialization of processing.

Accidental death, case number and police report required.

No claims will be honoured if name, surname and ID number on application do not appear on the death certificate.

Rules are subject to change at any time.

Premiums are payable monthly in advance on or before the 7th day of each month.

Only claims submitted within three (3) months of the end of the death will be considered for payment.

No claims submitted by fax or emails will be accepted

All funeral arrangement to be done through Pyramid Funeral Parlour.

Premiums will increase by 10 % every year.

We do not cross borders.

30% will be charged for all cash claims.
